Initiation of Consultation Procedure on “ Proposal of revision of Airport Charges 2025/2027”

The addressed airlines and category associations are hereby informed that GESAP, the management company of the airport of Palermo, has initiated the procedure of consultation on the Proposal of Revision of Airport Charges for the tariff Period 2025-2027, in compliance with the Model of Regulation of Airport Charges for Airports (Model A), published by the “Autorità di Regolazione dei Trasporti” (ART) (Authority of Transport Regulation) on 9<sup>th</sup> March 2023.

With the notification to “ART” of the initiation of the Consultation Procedure, published on the website of the Authority with the decision n. **06/2025 of 01.17.2025**, we hereby inform you that today we have launched the Consultation of Users (\*) on the Proposal of Revision of Airport Charges for the 2025-2027 Tariff Period for Palermo airport.

On the same date, in compliance with the provisions of the ENAC Guidelines 2018/0001 ed.1 of 09/08/2018, regarding the fees collected to finance the assistance provided to persons with reduced disabilities (PRM) referred to in Regulation (EC) No. 1107/2006, the Company published on its website the Annual Information Document for the determination of the PRM fee for the year 2025.


Users shall submit any requests for clarification and comments as detailed in the above website within the date of 02/20/2025.
